# HONG KONG NETBALL ASSOCIATION MINUTES OF ANNUAL GENERAL MEETING 7pm, 22<sup>nd</sup> June 2016

Meeting commenced at 7.05pm

Sherryn Hancock (SH), President of the Association welcomed members and declared a quorum was present in accordance with Article 64 of the Memorandum and Articles.

Accordingly, the meeting was commenced.

1. The Minutes of the 2015 Annual General Meeting held on the 23<sup>rd</sup> June 2015 were distributed to members. They had also been provided with the AGM notice and posted on the website.

Veronica Arnold noted that in the President's Report, it stated that Hong Kong climbed up the rankings to 4<sup>th</sup>, however it only maintained their rankings. This will be amended.

- --- In 2016, My Netball platform became live.
- --- HKNA was able to secure 2 major sponsors: Champion which is worth \$200000 in kind and Joint Dynamics. SH personally thanked both sponsors.
- --- This season there was a record of 7 divisions in ladies' league. SH gave special thanks to Shammin Azim.
- --- SH also thanked JC on the umpiring development throughout the season.
- --- SH thanked all council members for all their support.

## Jo Reed highlighted a few points of the **VP report:**

- --- It has been an extremely busy role that has evolved over the season which has highlighted many changes.
- --- Thanks to all coaches and umpires and and to the new sponsors.
- --- Big development in the umpiring section. JC to be applauded.
- --- Many strategies to be inputted with complaints such as incidence reports.
- --- Looking at elite pathways and hoping to expand in the future.
- --- There is a big pool of national selectors now. Online course you can do in Aust. JR encouraged everyone to do this.

## Shammin Azim (SHA) highlighted a few points from her league report:

- --- Drew attention once again that the league grew.
- --- We are losing one western court which may limit games each night and may need to limit teams for next year. SHA suggested any recommendations for next season.

#### Jenny Chadwick highlighted a few key points from the umpiring report:

- --- JC spent a lot of time at different venues this season to observe. This is just to help umpires, not criticize.
- --- JC thanked Emma Gregory, Ellie Stanley, Carol Chan, Mel Potgieter, Ron Arnold, Kahn Murray, Julie Hannaford, Rosanna Wong, Felicity Broadley, Shammin Azim, Sherryn Hancock, Kirsty Kruger and Ryan Cheng.
- --- There were 6 umpires courses run last year and 107 participated.
- --- Next course in Sept.
- --- JC congratulated all badged Umpires. Ryan Cheung received his B badge and there were 4 C badges: Jasmine Fung, Janice Wong, Canetti Chan and Daisy Wong.
- --- JC mentioned new rules. Good videos that have ben sent out. All active umpires have to redo the theory test.

## Connie Wong highlighted a few key points in her Coaching and Development report:

- --- Highlighted player's pathway to elite squads.
- --- Other role is to develop coaches and run foundation courses. Wants to run another course in sept. Date and time will be on website.
- --- Other role CW undertakes is junior league coordinator. However, she is stepping down next season.
- --- There is now 70+ teams in the junior league.

Emma Wall highlighted a few key points in her COO report:

- --- Was appointed 9 months' part time.
- --- Highlighted main projects were U/21 Asian championships / Laxton events/ website and project management.
- --- New website has been written and will go live in summer.
- --- EW thanked Jen Campbell for her help.
