No item for discussion in A.O.B. was received.

- Chairman welcomed members attending the AGM and confirmed quorum and declared meeting to convene.
- 2. Minutes of last Annual General Meeting (held on 28th June, 2011) was distributed to members. It was proposed to pass and adopt the Minutes as true and correct.

4. The League Convenor opened discussion regarding the Hong Kong Netball League By-Laws to the floor.

Match Balls issue at Aberdeen Outdoors were discussed. It was agreed that HKNA would provide match balls based on the fact that players and teams need to ensure they are returned to the desk after the games.

The number of games that a player has to play before the finals for a team was also discussed. Majority agreed on a set percentage for different divisions rather than a set number of games for all divisions. This was later decided as: Divisions 1, 4 and 5 (9 teams each) 6 games; Divisions 2 and 3 (10 teams each) 7 games; Division 6 (8 teams) 5 games;

This means that players need to have played this number of games during the season, on different nights to qualify for the final's series. 3 of those games MUST be in the final's team, before playing in the Final's Series. This works out to be generally 40%.
